With almost nine years of partnership, Rafael and Carine stand out for their skillful technique and musicality, but, above all, for the harmony of their dances. They have participated in more than 300 congresses and events around the world. Championships won between 2010 and 2016 include: the World Salsa Open in Puerto Rico, World Latin Dance Cup in Miami, Six Degrees Competition in Canada and World Salsa Championship in Atlanta

Rafael and Carine were born in Fortaleza, Ceará in the Northeastern region of Brazil. Since childhood, they have had great contact with dance, either during family parties or in the traditional forró dances of the Northeast. It was during this time that they learned to love what would later become the great passion of their lives.

Jonathan, founding member and Co Director of Alma Latina San Diego, began his career at the age of nineteen in Tijuana, Baja California Mexico, in the dance company Alma Latina Tijuana, where he began his training in salsa and bachata. His passion for dance has driven him to experiment new disciplines such as classic ballet, jazz, contemporary, and ballroom which allowed him to create his fused style of technique and flavor. He is ranked amongst the most important dancers in California and Mexico and is a Multi-Time World

Champion in Salsa Teams 2010-2013, and was Top 3 in couple division in 2011. He has given classes all over the world in places such as: Africa, Japan, Singapore, New Zealand, Canada, Alaska, and South America.

Natasha is trained in Jazz, Contemporary, Lyrical, Tap, Afro-Cuban, Salsa, Hip-Hop, Punta, Bachata, Merengue, Cumbia, and Swing. Natasha started to dance at the age of 3 and currently practices 4 hours a day. She has traveled to Japan, Turkey, and half of the United States. Her favorite place to be is her dance studio. Natasha's favorite Disney character is Stich from Lilo and Stich, and her favorite TV show is Once Upon a Time. Natasha loves the color neon green, and her favorite numbers are 3 and 23. She is a three time World Latin Dance Cup Junior Couples Division Champion.





Uriel Garcia and Vera Rowe

Uriel Garcia and Vera Rowe are nine-time World Salsa, Bachata and Hustle Champions. Since the beginning of their partnership in 2012, they have traveled all over the U.S. as well as internationally to teach, perform, and compete in places such as Canada, Spain, Australia, Ireland, Italy, Hong Kong and China.

Vera Rowe was born in New York City and graduated from LaGuardia High School of The Performing Arts as a dance major. Aside from being a dancer she was also a USA gymnast for 20 years and competed for Penn State University as a NCAA Division I athlete. Vera holds a Masters Degree in Mathematics from Boston University. Uriel Garcia was born in The Dominican Republic and came to the USA when he was six years old. He was a competitive athlete in sports such as football, soccer, volleyball, basketball and track and field.

Uriel grew up dancing various forms of Latin dance; however, he started dancing salsa at the age of 20 and was trained by his older brother, Darlin Garcia. Their most recent accomplishments include becoming The 2015 World Cabaret Salsa Summit Champions, The 2015 World Cabaret Bachata Summit Champions, The 2015 World Hustle Champions and The 2014 World Bachata Masters Champions. They have also been finalists at The 2012 World Latin Dance Cup, The 2013 Puerto Rico World Salsa Open and The 2013 Hong Kong World Salsa Championships. Uriel and Vera currently reside in North Miami, Florida, USA where they run their school, UV Latin Dance Academy.

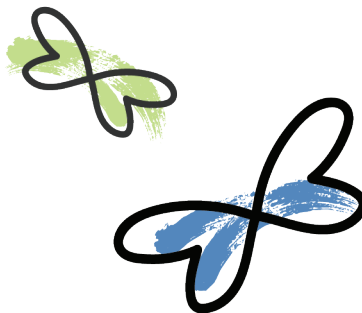

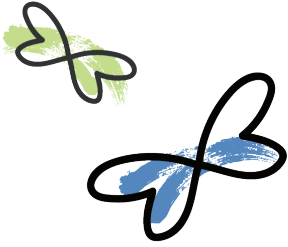

Where did the name "The Rainbow Project" come from?

The Rainbow has always been used as a symbol of hope. It is a promise that something better is sure to follow. In the midst of a rain storm, the sun appears and creates a rainbow. And every child knows the legend of the pot of gold at the end of the rainbow. We decided to use it because it was a simple, positive and friendly name that young children could easily say and remember.



The Rainbow Project

Established in 1980 by Sharyl Kato, Executive Director, *The Rainbow Project* is a local non-profit counseling clinic that provides crisis treatment and early intervention services for young children and their families who have experienced or witnessed trauma, including child sexual abuse, neglect and/or domestic violence. The clinic has provided services for over 10,700 children and over 10,200 caregivers. The Rainbow Project is well known not only locally, but also nationally for pioneering techniques in prevention, trauma recovery and developing programs which have been shown to break the cycles of family and community violence.



The Project's unique "hands on" approach is unlike that of any other therapy clinic because it includes home, day care and school visits. In fact, this is one of the reasons why working at Rainbow is part of the curriculum for all University of Wisconsin, Department of Psychiatry, Child Abuse and Adolescent Residents who elect to specialize in child psychiatry. The Rainbow Project works closely with all levels of law enforcement and the courts not only to protect the rights of abused children, but also to bring the offenders to justice. Many of Rainbow's clients are referrals from the legal system who are the victims of severe tragedies in our community.

Services of the Rainbow Project

Rainbow Project services are intended to...

- Promote positive change within families, including building, strengthening, and supporting healthy parent/child relationships (improving child behaviors and development, and providing parent education and support).
- Prevention, early intervention, and treatment for families affected by family violence (including services to families with patterns that place members at risk for maltreatment or future mental health concerns).
- Advocate for the mental health needs and support of families and children in the community
- Strengthen the capacity of the larger community to prevent, respond to, and support those who have experienced trauma (including community violence, grief/loss, natural disasters, child maltreatment, domestic violence, substance
- Abuse, mental illness, and adjustment to other life transitions.

Services offered may include one or more of the following:

- Comprehensive diagnostic assessment and developmental evaluation, with emphasis on social-emotional development and behavior, for young children and adults.
- Assessment of parent-child interaction and family relationships
- Referral services to other specialized community services for family members
- Child play therapy
- Trauma-Focused Cognitive Behavioral Therapy (TF-CBT)
- Adult treatment and counseling with individuals, couples, family, or groups

- Parent education in individual, parent-child play sessions, or group settings
- In-home treatment
- Interagency coordination, case management, and advocacy
- Consultation services with teachers, foster parents, nurses, and others involved with the family
- Individualized service planning
- Evaluation and follow-up services

Speakers Bureau & Consultation Services

In addition to their direct clinical work with children and families, the Rainbow Project therapists also provide training presentations, consultation services and technical assistance on a local, state, national and international level.

Topics requested and provided include a broad range of issues focusing on recognizing, preventing and responding to the needs of children, parent's/caregivers and families who have experienced trauma, including child abuse, neglect, domestic violence, child sexual abuse, community violence, grief/loss, natural disasters, serious physical/mental illness, incarceration of a family member, substance abuse and social/emotional development. Intended audiences include school staff, early childhood educators, childcare providers, social workers, advocates, law enforcement, those representing the court system, medical field, other mental health and human service providers, foster parents, after school and community center staff, volunteers, caregiver groups and shelter staff.

Each presentation is tailored to a specific audience and includes conference presentations, in-services and workshops, from 1-2 hours to a half or all day training that includes hands-on activities, as well as power point, role play and other materials, resources, references and learning demonstrations.

WHEREAS; the Rainbow Project has been advocating for the mental health needs and support of families and children in the community since 1980;


